

AUSSIE DOG TERMS AND CONDITIONS



Placing order:

All orders placed are subject to confirmation and acceptance by Joseph Parsons Nominees Pty Ltd., this includes the Eway orders, eg. direct deposit etc.

To minimise errors and improve efficiency, orders should be placed using our on-line E-Commerce ordering system whenever possible. Other forms of ordering are not accepted. If you are having difficulties ordering off our site, we can be contacted on sales@aussiedog.com.au.
